2. Set up Time/Strike and Teardown Time: Client Initials _____

Client is fully responsible for providing a timeline with adequate time for setup and access to the event. Client is also required to provide a Strike and Teardown time with adequate time for Strike and Teardown of installation. If Florescio Events is not able carry out Strike and Teardown on the set Strike and Teardown time at event location, a grace period of 60 minutes will be implemented. A \$200/hr. fee will be charged to the client after a 60-minute grace period has been utilized unless an extension is requested 24 hours prior to the event date.

3. Outdoor Events: Client Initials _____

For all outdoor events, classic balloon décor, deliveries, and balloon sculptures, Florescio Events does not guarantee any of its products, rentals or installations to withstand inclement weather. All services are rendered and non-refundable after installation is complete.

4. Safety and Liability: Client Initials _____

Client is responsible for all of its purchased products after installation is complete. Client is responsible for supervising all use, and preventing all misuse or abuse of helium, balloons, equipment and material related during the event. Client hereby agrees to hold harmless and without liability, Florescio Events LLC and all principals, owners, or employees from any of the following:

- Helium inhalation or injury from lack of oxygen
- Slipping on broken balloons
- Latex allergies
- Children and/or adults having access to balloons/materials relating to installation before, during or after events
- Children and/or adults putting balloons in their mouths and choking
- Eye/facial/body injuries from popping balloons
- Heart attacks from balloons popping
- Hearing loss due to balloons popping
- Lesions, abrasions, suffocation, choking, loss of sight, loss of hearing, dizziness, drowsiness, loss of consciousness, broken body parts, death or any other personal or property damage caused or alleged to have been caused by balloons popping

5. Cancellation and Postponement: Client Initials _____

In the event that the client cancels or postpones any installations, rentals and/or décor for the event the deposit will not be refunded. A credit will be issued in the amount of the deposit which can be applied to any future event for up to one year from initial event date. Should the event be cancelled within a week of the event date a credit will be issued in the amount of the paid in full balance which can be applied to any future event for up to one year from initial event date.

6. Design Change/Revisions: Client Initials _____

Any design changes to the description of event outlined in section 1 after contract is signed will be subjected to a new estimate. Florescio Events will not take any revisions or changes to the Description of Installations/Services within a week prior to the event.

7. Payment Terms and Conditions: Client Initials _____

It is agreed upon by the Client and Florescio Events LLC that the balance is payable in full to Florescio Events LLC, no later than 1 week prior to the event date to guarantee delivery of the order. A 50% of the balance is to be paid as a deposit upon signing this contract to reserve services on the date of event. Deposits are non-refundable.
